- Events such as school excursions (where students are leaving school or board premises on a school-sponsored activity) will not be posted prior to the event. However, vague posts that do not include the time and location of the excursion are permitted.
- Information and/or calendar entries about extracurricular activities will not be posted prior to the event. This includes meetings, practices, games, etc. However, vague posts that do not include the time and location of the activity are permitted.
- Information about events that are open to parents and the public can be posted prior to the event taking place.
- Student work cannot be posted on social media without the informed consent from students' parents/guardians.
